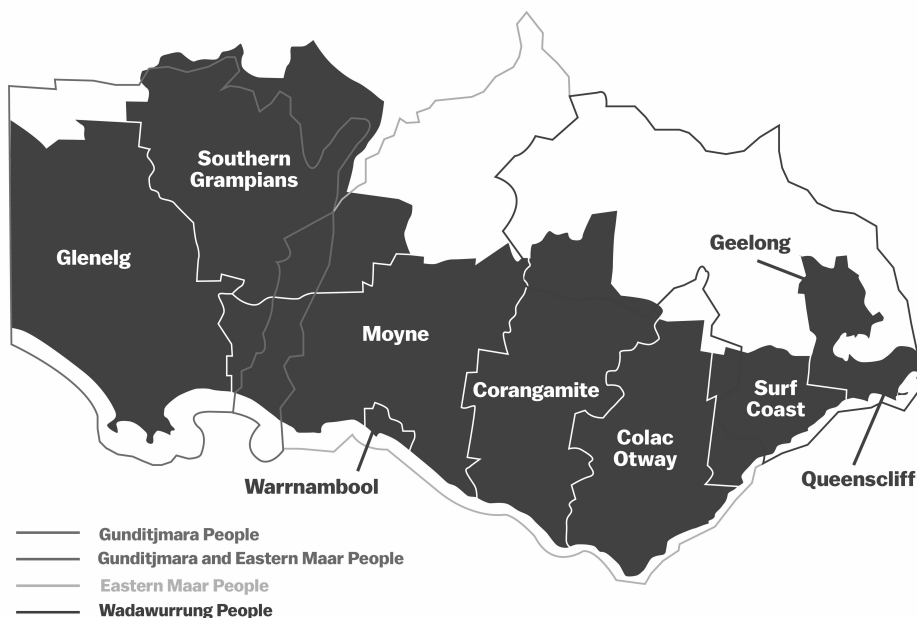
Women's Health and Wellbeing Barwon South West (WHWBSW) is an independent, not for-profit, regional women's health organisation committed to gender equality and great practice health promotion. In short, we strive to improve women's lives.

We are conducting consultation to identify the barriers healthcare and service providers experience when delivering sexual and reproductive health care in order to improve service delivery and coordination. The consultation also seeks to understand the barriers women and gender diverse people experience when accessing sexual and reproductive health services in the Barwon South West.

This survey is open to all people who work in the Barwon South West region and currently deliver sexual and reproductive health services.

Barwon South West

The Barwon South West region spans the lands of three Traditional Owner groups – the Gunditjmara, Eastern Maar and Wadawurrung – and the clans that reside within them. The region includes nine local government areas: Borough of Queenscliffe, City of Greater Geelong, Colac Otway Shire, Corangamite Shire, Glenelg Shire, Moyne Shire, Southern Grampians Shire, Surf Coast Shire and Warrnambool City Council.

Introduction

What is this project about?

Women's Health and Wellbeing Barwon South West are leading a consultation project in 2025, with the objective to:

- Identify specific barriers women, girls and gender diverse people encounter when accessing sexual & reproductive health services in the Barwon South West region.
- Identify specific barriers service providers face when delivering sexual and reproductive care in the Barwon South West region.

The consultation will involve the delivery of surveys, interviews and focus groups. This survey is for service providers working in sexual and reproductive healthcare, including clinicians (GPs, nurses, pharmacists) and non-clinicians (educators, social workers, public health officers etc.)

Women's Health and Wellbeing Barwon South West will publish a full and summary report of the survey, focus group and interview findings. These findings will be used to create a regional action plan for our region, to improve access to and delivery of sexual and reproductive health services in the Barwon South West.

What will I be asked to do?

If you agree to participate you will be asked to complete an online survey. The survey takes approximately 15-20 minutes to complete and asks questions about;

- you (for example, your local government area and scope of practice)
- your provision or referral of abortion, sexually transmitted infections, chronic reproductive conditions and postpartum and maternal health services
- your workforce development needs

We will also ask you for your email address. This is to provide you with a copy of the survey results and invite you to an online webinar sharing the results, if you are interested. You do not have to provide us with your email address if you do not want to. Email addresses, when provided, are collected and stored separately to survey responses and cannot be used to identify your responses.

You will also be asked if you would like to be contacted to participate in further consultation (for example, a telephone interview, an online interview or focus group) providing another opportunity to discuss your experience and further explore topics in this survey. If you consent to being contacted about the focus groups and interviews, you are under no obligation to participate.

What will happen to information about me?

You will never be personally identified in any results published from this survey. Any personally identifiable information collected (for example, your email address) will be collected and stored separately from your survey responses. The survey data will be stored securely on a server at the Women's Health and Wellbeing Barwon South West for the duration of the project, and for a period of 7 years after the final publication.

What are the possible benefits?

Participants who complete a survey will have the opportunity to win one of 4 x \$100 vouchers. Data collected in this research will be used to enhance delivery and coordination of sexual and reproductive health services in the Barwon South West region, and your participation can help shape support and improvements needed in women's health service delivery. Some people may find benefit from sharing their personal experience and may feel they have helped to raise awareness of issues delivering sexual and reproductive health services in the area. However, there is unlikely to be significant immediate benefits to individuals. We value and appreciate the contribution from all participants in this project.

What are the possible risks?

There are minimal risks to participating, however you may feel discomfort at some of the survey questions. Participation in this survey is voluntary, and you can skip any questions you do not want to answer or exit the survey at any time by using the exit button in the top right corner.
